Day 1: Our getaway begins with a visit to the thriving village of **New Paltz**. Situated in the Shawangunk Mountains, New Paltz is home to fantastic farm-to-table restaurants and quaint boutiques. We will enjoy lunch here before making our way over to **Hyde Park** to tour the **Vanderbilt Mansion**. This estate, inside and out, offers a great perspective of the wealth and excess of the Gilded Age and one of its most prominent families. View original furnishings, manicured landscapes, natural woodlands and formal gardens. Later, check into the **Poughkeepsie Grand Hotel**. Dinner is included this evening at a local restaurant. (D)

Day 2: Today we will visit Eleanor Roosevelt's Val-Kill and gain an interesting perspective of this most influential first lady. After, we will travel to the gracious town of Rhinebeck. Discover the oldest inn in America and explore its diverse collections of shops and restaurants. This afternoon we will head over to the Old Rhinebeck Aerodrome to view one of the largest collections of early aeroplanes in the world. Enjoy a stunning air show* (weather permitting) featuring aircraft from the World War I era. Dinner is included at a local restaurant. (B,D)

Day 3: Savor breakfast before checking out the Walkway Over the Hudson, the world's largest elevated pedestrian bridge. This path through history offers awesome views of the Hudson River and Valley area. Next we will visit West Point, the oldest military academy in the United States. Tour this magnificent place and see the Old Cadet Chapel, Trophy Point, Battle Monument and the Plain. Walk the grounds of the massive campus that has produced some of our country's greatest generals and leaders, from Ulysses S Grant to Dwight D Eisenhower. After our tour we'll enjoy lunch at the West Point Officers Club located right on the grounds of the Academy. (B,L)
